### Planning and Compulsory Purchase Act 2004 Rutland Local Development Framework

#### Statement of adoption of the Rutland Core Strategy Development Plan Document and publication of the Inspector's report

Notice is hereby given under Regulation 36 of the Town and Country Planning (Local Development) (England) Regulations 2004 that Rutland County Council adopted the Rutland Core Strategy Development Plan Document (DPD) on 11 July 2011.

The Core Strategy sets out the vision, objectives, spatial strategy and policies for development in Rutland up to 2026. It applies to the whole of the administrative area of Rutland County Council.

Any person aggrieved by the Core Strategy may make an application to the High Court under Section 113 of the Planning and Compulsory Purchase Act 2004 on the grounds that:

- a) the document is not within the appropriate power;
- b) a procedural requirement has not been complied with.

Any such application must be made not later than the end of the period of six weeks starting from the date of the adoption of the Core Strategy on 11 July 2011.

The recommendations of the Inspector who carried out the independent examination of the Core Strategy and the reasons for those recommendations have also been made available for inspection under Regulation 35 of the above-mentioned Regulations.
