Your request for information has now been considered and the information requested is provided below.

Request/Response:

I am looking to gather information on IT Users & Devices in use at the Council and request the following information please:

1. How many IT users in total are there working for the Council?

Answer: Rutland County Council has software that shows details of users that have accessed the network which can be used to provide a figure of IT users on the network. This shows that since 29th August that 534 distinct usernames have logged onto the network and so can be consider IT users. Some of these might be system accounts and bot individual people. If this figure is not acceptable then the total of the Desktop PCs, Laptops could be used.
