Ketton Parish Council determines a precept. We collect this precept through council tax and pay it over to the Parish.

The precept for Ketton Parish Council is as follows:

2011/12	£50,375

Those in Ketton Parish also pay council tax that goes towards the County Council, police etc. The amount levied in each year from Ketton can be calculated by multiplying the
