- personal wheelchair budgets
- personal health budgets

1. Could you provide details of any service(s) you commission to provide Independent Advocacy Support to adults and children or young people receiving aftercare support under section 117 of the Mental Health Act?
2. Could you provide details of any service(s) you commission to provide Independent Advocacy Support to people going through Continuing Health Care processes (adult) or Continuing Care (children)?
3. Could you provide details of any service(s) you commission to provide Independent Advocacy Support to people accessing personal wheelchair budgets?
4. Could you provide details of any service(s) you commission to provide Independent Advocacy Support to people accessing or using personal health budgets processes (both adult and children)?
5. We would be grateful if you could tell us which services are commissioned.
6. And lastly, we would be grateful if you could indicate the budget allocated for any of the above types of advocacy?
