Thank you for taking the time to organise these 'Future of Rutland' events/conversations and for putting together these summary reports. I really appreciated being able to voice concerns about a variety of issues, especially on the climate and environmental crisis. I do hope they will help to positively shape the future of Rutland for our community and generations to come. I am writing to you with some concern over the interpretation of the 'Climate Crisis' answers in the summary report. You open by saying that "a number of residents argue strongly that there is no climate crisis", followed by "others do believe...". Then 4 out of 6 of the example comments that follow feature strong climate denying or 'doomist' (it's too big a problem so why bother with action..) type comments. I believe this not only misrepresents the consensus opinion in Rutland (see the overwhelming majority choose 'global warming' as the number one concern), but it's akin to taking a poll on people's 'opinions' about whether the Earth is spherical and then expressing 'both sides' as equal. Or worse, leading and over-representing the 'flat-earthers'. This is not a matter of opinion. Over 90% of scientists are in agreement. What should be summarised from the questionnaires, are the opinions on how we, as a community, can make a contribution in tackling this global crisis. I sincerely hope this section will be amended to reflect residents' opinions about how we can tackle climate change, rather than be dominated by ignorant comments that are not based in fact.

Introduction: Participants in this conversation have been invited to comment on this narrative summary report and in particular to highlight any input which may have been missed when drafting the report. Some dangers which have been identified as requiring the most urgent attention are : - Global warming - Diversity of Plants and animals - Air pollution - Plastic waste Over the last couple of years there has been much discussion around the nature and form of the Council's Local Plan review. Time and again, when talking about this aspect of the Rutland Conversation, it has been pointed out that the Local Plan is one of the most important tools in the armoury of a Local Authority to influence the future of its area. The Local Plan should be framed around the delivery of the Vision emerging from the Conversation. Bizarrely RCC is doing it the other way round. Not only has RCC seemed to identify a much less sustainable approach to the pattern of future development than previously, it has also embraced an approach geared to delivering significantly more development, particularly housing, than any local needs assessment requires. As a result, all these laudable climate and environmental objectives are in practice going to be much more difficult to improve and could be considerably worsened. There is a root cause underlying all of these dangers facing Rutland and that is over development of the County. This has arisen continuously since around 2014 when housing development has been permitted to increase in each following year to a level of between 200 to 250 dwellings per annum compared with the independently assessed Objectively Assessed Need of around 130 to 160 completed dwellings per annum over that same period. At present, the planning policy trajectory is to vastly increase the rate of over-development in Rutland The permitted over-development leads directly to an increase in the four dangers referred to above, and it leads indirectly to many other undesirable impacts worrying the Rutland Community which have also been referred to in this and other narrative summary reports. What have you missed? There is no mention of the fact (in the Narrative Summary Report) that almost all of the responsibility for adverse impacts on climate change and the environment resides with the Local Planning Authority. This means both the political elements and the professional staff which together comprise the LPA. If there is to be any significant arrest to deterioration and lowering of risks in the area of climate change and the environment, let alone any improvement in conditions of life for the community in Rutland, the present policies and the implementation of them by the LPA will need to be significantly enhanced. The National Planning Policy Framework contains clear guidance that biodiversity net gain is required by every development. In earlier versions of the NPPF the policy guidance was that there should be no net loss of biodiversity. None of this guidance has so far been implemented by RCC LPA Applying a metric to measure biodiversity and charging the developer for the replacement of any loss of biodiversity occasioned by the developer is a fundamental policy requirement in a Local Plan to protect the environment and to slow climate change. Treating the environment as a natural asset and charging developers to maintain and enhance this asset is an essential implementation tool to be rigorously applied by Development Control. We need amendments to the Regulation 19 Local Plan to introduce clearly defined policies in this area. We need Supplementary Planning Guidance and operational instructions developed for Development Control to implement these policies. I have submitted detailed evidence to the Future Rutland Conversation from Warwickshire County Council, sufficient to enable comparable policies to be developed in Rutland with ease. The submitted evidence includes guidance on implementation. Warwickshire have been operating and developing the application of charging developers to achieve biodiversity net gain since around 2003 and are willing to advise and assist RCC wherever necessary. Conclusion The present dangers for the environment and climate change in Rutland arise from the policies and decisions of the Local Planning Authority, which, for the past seven years at least, have been failing our County. The policies contained in our presently adopted Local Plan have not been implemented. Please ensure that this present opportunity is taken to make significant improvements in our planning policies and the implementation of them. C J Bacon. 15th July 2021
