I would like to to add some feedback to this aspect of living in Rutland. Whilst I know that the council are not responsible for Rutland Water as it is such a large part of the recreation facilities of our county I think comments on it are relevant. It is a great resource both for residents and visitors to the county alike. However there are a number of aspects which could be greatly improved. It is very difficult if not impossible to find spaces/walls alongside the water where dogs can be let off leads and most dog walkers like to let dogs off leads for at least part of each walk this makes using RW an unusable resource. On a separate front...the ownership of cafes by AW means that they are of low quality and are therefore largely unused certainly by residents...it would be nice to see higher quality outlets so that this aspect of RW can be better enjoyed. Ideally more high quality restaurants with views of the wate would also be a big advantage...at present Hambleton Hall is one of the few places where refreshments can be enjoyed whilst also viewing the water and that's a shame. Even whilst driving there are relatively few places where the water can be viewed from. Normanton car park is lovely but only one viewing point on a huge lake. I appreciate that this may relate back to when the lake was commissioned in the 80's and was first and foremost a water supply resource (quite rightly) but times have changed and this is now a major recreational resource (and attraction for visitors to Rutland) for many people and as such it's charter and services to the community should be adapted and improved to reflect its present usage and how it could better fulfil our needs and expectations as residents and visitors.
